

INFORMATION AND CONDITIONS



These cars will be confirmed on request only

- Minimum hire period: 3 days.



Normal office hours: 09:00 till 13:00 and 15:00 till 19:00

Normal airports hours: 07:00 till 24:00

AIRPORT TAX: – An airport tax of **€25,00 per rental** will be charged directly to the client.

BABYSEATS: - May also be supplied on request. The cost for these will be **€5,00 per day** charged directly to the client. Maximum **€70,00 per rental**.

PASSENGER INSURANCE: - May also be supplied by Budget. The cost for this will be **€3,50 per day** charged directly to the client.

ADDITIONAL DRIVER: - For each additional driver mentioned on the rental agreement we will charge **€30,00** directly to the client.

YOUNG DRIVERS: - All drivers between 21 and 23 years old must pay directly to Budget an additional tax of **€3,00 per day**.

Deliveries / Collections outside of the office area: charged directly to the client:

Carvoeiro/Faro: **€35,00**

Faro/Lisboa – Lisboa/Faro : **€72,00**

Lisboa/Porto – Porto/Lisboa : **€65,00**

Faro/Porto – Porto/Faro : **€72,00**

INSURANCE TO SPAIN: If the client want to go to Spain must pay additional **€65,00 per rental** to extend the insurance beyond the border.

COLLECTING IN ADVANCE: Through this confidential rate we shall not refund either the client nor the agency involved in the booking for the rental days which were not used.

NOTE: For each delivery or collection outside of our normal hours at airports a fee of **€30,00** will be charged directly to the client.

The car type could be changed for others at same category or superior.

To be covered by Insurance, drivers must be duly mentioned on the rental agreement.

The travelling assistance will be supported by Budget.

VERY IMPORTANT

The client (whether drive or not) is always responsible for a bail on the amount of **€1.000,00 for groups A, B and C; €1.500,00 for groups D and H; €2.000,00 for group E; €2.500,00 for groups F, G and I; €3.000,00 for groups J, K, L and M; and €3.500,00 for group N**, in case of a self-provoked accident, in case of damages caused by acts of vandalism, in case theft of the vehicle or of theft of any of its accessories, as long as the driver is unable to identify the guilty party.

This payment must be made upon the delivery of the car, in cash (euros or foreign currency) or by credit card.

The referred payment will be refunded to the client at the end of the rental, in case no accident has taken place, as well as no damages have been caused to the vehicle by acts of vandalism, theft of the vehicle or of any of its accessories.

This situation can only be eliminated with the payment of an insurance of **€10,00 per day for groups A, B and C; €12,50 per day for groups D and H; €15,00 for group E; €20,00 for groups F, G and I; €22,00 for groups J, K, L and M; and €25,00 for group N**. This amount has to be paid by the client when receiving the vehicle.

In case of accident by our car driver's fault taking into consideration Portuguese law, insurance companies decline any or all responsibility for that driver of all damages caused to the hired vehicle or to third parties whenever it is detected that the driver was driving under the influence of alcohol, narcotics, drugs or toxic products or by insanity of the driver.

We also take this opportunity to inform that even if the car's driver is not under the influence of any of the above items but by any means also destroys our car by his own fault we shall not refund any amount for the time left to complete the rental and we only give another car through a large deposit that may cover eventual damages that can be caused to the new car.

We would like clients to be well informed about the above situation.
